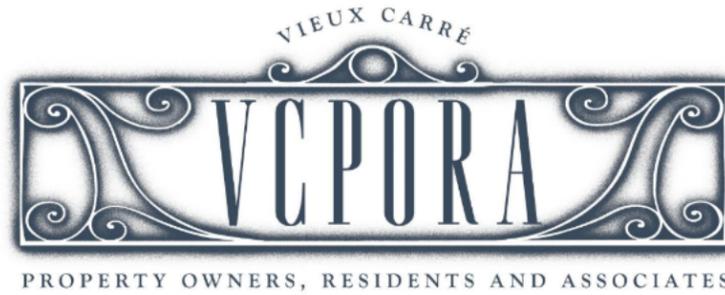



Willie's Chicken Shack Update

Regretfully, our efforts to [appeal](#) the Willie's Chicken Shack at [601 Chartres](#) as a Standard Restaurant were unsuccessful. Following three consecutive deferrals, the Board of Zoning Adjustments argued that the defining criteria for Fast Food Restaurants are insufficient in differentiating them from Standard Restaurants. They decided this murky language allowed for multiple interpretations, giving the Director of Safety and Permits wide latitude in his determinations, ultimately upholding his decision.

Representatives from French Quarter Citizens, Faubourg Marigny Improvement Association, and Preservation Resource Center spoke in favor of the appeal, as did numerous neighborhood residents. Over [100 letters](#) were submitted in support of this effort to protect the diversity and vibrancy of the neighborhood. **Thank you for that support!**

Our arguments included how the operations, design, and signage of the [601 Chartres](#) location closely mirror those of the eight other downtown Willie's Chicken Shacks. Furthermore, ordering at a counter and having a cashier drop off a disposable basket of food does not constitute "table service."

Just to remind you, here is the **definition of a Fast Food Restaurant** from the Comprehensive Zoning Ordinance (CZO):

An establishment, which may be part of a chain of fast food outlets, that is oriented around the quick-service of meals for on-premise or off-premise consumption. Typically, a fast-food restaurant's design or principal method of operation includes three (3) or more of the following characteristics:

- 1) a permanent menu board is provided from which to select and order food;*
- 2) standardized floor plans, architecture and/or sign design are used over several locations;*
- 3) customers pay for food before consuming it;*

- 4) a self-service condiment bar is provided;
- 5) trash receptacles are provided for self-service bussing;
- 6) furnishing plan indicates hard-finished, stationary seating arrangements;
- 7) drive-through service is offered;
- 8) most main course food items are prepackaged rather than made to order.

Fast food restaurants may not offer alcoholic beverages for sale. Table service by restaurant employees is not provided.

The CZO is the result of thousands of hours of community input. Ignoring this language undermines its intent and use as a guiding framework for community priorities. Monday's BZA decision is particularly alarming because their readiness to point to, rather than challenge, imprecise language will open the door to other Fast Food and Bar operations in areas where neither are permitted. We stand firm that this business meets this definition, both as it is written and in its intent.

Though the outcome was unfortunate, we know that the effort was not made in vain. We will be pursuing new strategies to firm up the language in the CZO so that it can appropriately guide development in our communities. We hope you will continue to support us as we move forward in the fight for clear, enforceable regulations that uphold the French Quarter as an international historic treasure, valued by all, for its authenticity and integrity.
