## FQ EDD Update

On Thursday, Jan 14, the City Council's French Quarter Economic Development District (FQEDD) committee [met to consider the language](#) for an April 24 ballot measure that would reestablish the "Quarter for the Quarter" .245% sales tax for supplemental security services in the neighborhood. The original renewal failed on December 5 with 67% of voters [opposing an uncertain future](#) for the tax.

The following language was adopted:

*Shall a .245% increase in the sales tax be levied within the boundaries of the French Quarter Economic Development District ("FQ EDD") (with the exception of such a levy on hotel rooms) to be collected on the sale at retail, the use, the lease or rental, the consumption and storage for use or the consumption of tangible personal property and sales of services within the boundaries of the FQ EDD for a period of five years, beginning May 1, 2021 and ending April 30, 2026 (an estimated \$2 million reasonably expected at this time to be collected as a result of the levy per year) for the purpose of funding POST Certified supplemental police patrols and homeless assistance services, with the initial \$2 million collected in any year dedicated to supplemental police patrols and any additional revenue to be divided between additional patrols and public safety programs (including homeless assistance), and administered by the French Quarter Management District for fiscal and operational oversight of the FQ EDD Trust Fund and services provided by such fund and subject to quarterly budget and expenditure reports to*

the City Council, to facilitate economic development within the FQ EDD?

VCPOPRA supports this ballot language and submitted the following comments into the record:

"The safety and well-being of our French Quarter community of residents, workers, business owners, and visitors is paramount to ensuring a positive quality of life and economic recovery in this important neighborhood. We endorse this ballot language as it prioritizes the use of collected tax revenues to fund POST-certified NOPD supplemental patrols within the district and homeless assistance services. Further, we find that the French Quarter Management District is best poised to continue administering these programs given their leadership representation by community stakeholders and past performance in managing the Supplemental Police Patrol Program."

During the meeting, an amendment to remove the language empowering administrative and operational oversight to the FQMD was introduced by District E Councilmember District Cyndi Nguyen. That amendment failed 4-2.

Now that the ballot language has been approved, the next steps are to create the Cooperative Endeavor Agreement between the FQMD, the FQEDD, and the Mayor that will specifically outline the roles and duties of each. We will continue providing updates on this important security measure for the French Quarter.



## Moving New Orleans Bikes & Bike Share

Workers completed improvements to bicycle infrastructure along N Peters, Elysian Fields, and St. Claude Avenue earlier this week. The project, dubbed the [Marginy/French Quarter Transportation Network](#), is part of [Moving New Orleans Bikes](#), a campaign that aims to construct 75 miles of new low-stress bikeways as part of the City's efforts to improve roadway safety for all residents. The project now provides people on bicycles with a parking-protected travel lane on N Peters along the French Market heading toward the Marigny.

The completion of this construction comes as the City announces a partnership with a new local nonprofit organization, Blue Krewe of New Orleans, to revive the bike share program previously operated as Blue Bikes. (Blue Bikes operations were suspended last spring.) Incubated and supported with start-up funding from the Greater New Orleans Foundation, Blue Krewe has coordinated with Mayor Cantrell and the Office of Transportation to begin bike-share operations by September 1, 2021.

The initial CEA stipulates that Blue Krewe must provide 350 bikes, locks, and enough dedicated racks to hold at least 575 total bikes. Although details are still being finalized, there is also speculation that existing Blue Bikes racks will be utilized, e-bikes may return, and that fare types may differ. 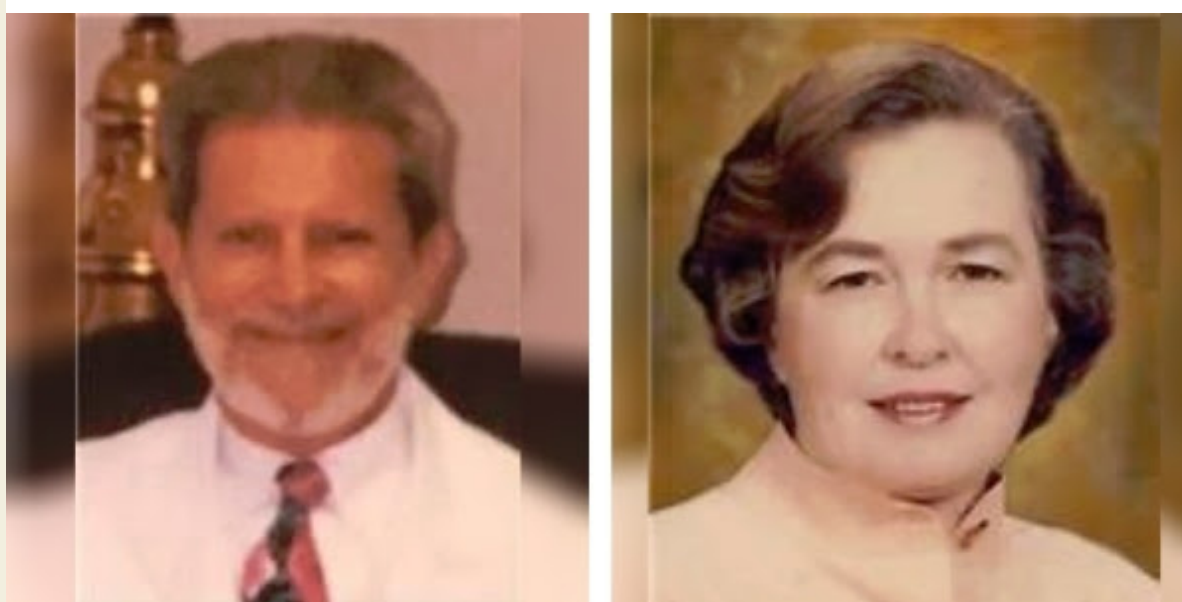
## Filming in Congo Square
