




## At Home in the Vieux Carré Kickoff

Please note that in keeping with the City of New Orleans [Phase 3 reopening restrictions](#), this event will be limited capacity and masks will be required when not actively drinking.



## Short Term Rental Update

Yesterday, the City Council's Governmental Affairs Committee asked for clarification from the Office of Safety & Permits on Short Term Rental (STR) adjudication efforts. This followed the release of a [Lens report](#) earlier in the week that stated that only \$1,500 fines had been collected to date, though it was later noted that the figure was based on incomplete records the City provided via a public records request.

Safety & Permits Director, Tammie Jackson, revealed that nearly \$408,000 has been collected in STR fines since 2019. Additionally, 270 properties have been delisted by platforms since September of 2020 and 36 fraudulent Homestead Exemptions have been revoked since March of last year.

All parties agreed that, despite the inaccurate data previously reported, more enforcement is necessary for the 2019 STR ordinance to be fully effective. If the anticipated fines for illegal operators are consistently applied and collected, the enforcement arm of this legislation will pay for itself. Ms. Jackson said that her department will now reserve one full docket (9 cases) each month for STR adjudications, with hopes of expanding that to two dockets. [Read more here](#). ## 5G Update

The Vieux Carré Commission and Mayor's Office of Utilities have been working on [design guidelines](#) to direct the location, aesthetics, and installation of this new infrastructure. They have compiled a [map of the carriers' approved locations](#) and pole designs for reference. We are currently working with the City to make a higher resolution map available for public review. Please note:

1. Within the French Quarter, 5G poles will be introduced as streetlight poles with the technology built into the structure. All new 5G poles will replace existing streetlight or traffic poles, creating zero net gain of infrastructure poles in the public right of way. Most new poles will be located near a corner or mid-block.
2. There are nearly 700 existing poles in the French Quarter. Overall, there were 289 5G pole installation requests in the French Quarter. Of those, half were denied and half were approved locations, meaning around 120 proposed 5G streetlight poles will replace existing streetlights.
3. The Mayor's Office of Utilities is requiring collocation by carriers, meaning sharing of an individual pole for different technologies, on 5G poles whenever possible.
4. New poles are prohibited on block faces of purple-rated, significant buildings and spaces like the St. Louis Cathedral and Jackson Square, the Old U.S. Mint, and the Old Ursuline Convent, etc.
5. The French Quarter has three streetlights per block, so the Office of Utilities is trying to limit 5G streetlight pole installation to 1 per corner and 2 per block in most cases. The City Council is expected to take up the design guidelines shortly and we will provide more information as we receive it.

## COVID-19 Restrictions Update

The City of New Orleans reiterated today that it is not changing its mask mandate, but that event limits will increase to 250 people indoors and 500 people outdoors, with masks and distancing required in both settings. Most establishments and retail sectors currently at 75% capacity will increase to 100%. Gyms and stadium guidelines will remain the same for the time being as well. As a reminder, the City of New Orleans is also offering vaccines at the Ernest N. Morial Convention Center. The Regional Transit Authority (RTA) is providing [free shuttle service](#) to the Convention Center Hall from Duncan Plaza, the West Bank RTA Park and Ride, and the New Orleans East Walmart. Complimentary parking for individuals driving to the Convention Center will be available in Parking Lot F, directly across from Hall J. New Orleans Emergency Medical Services continue to administer vaccine in the homes of residents who are homebound.



The City of New Orleans announced this week that it will [increase parking enforcement](#) to a pre-pandemic levels of patrol. Enforcement hours for ticket writing's field staff is 7:00 a.m. - 10:00 p.m. Monday - Saturday and 7:00 a.m. - 7:00 p.m. on Sunday. Enforcement hours for towing remains 24/7.
